Spectrum Aquatics warrants that its product will be free from defects in materials and workmanship as well as maintain structural integrity for the periods listed below from the date of invoice and once Spectrum has been paid in full. This warranty is in effect only if the product has been assembled and installed strictly in accordance with the setup instructions provided by Spectrum good construction practices and has been subjected only to normal use and exposure.

- **2-Year Limited Warranty on Plastics.**
- **2-Year Limited Warranty on Steel Structure.**
- **2-Year Limited Warranty on Decks.**
- **1-Year limited Warranty on Hardware.**
- **1-Year Limited warranty on workmanship.**

The Limited Warranty excludes abnormal conditions, contingent liability, cosmetic defects such as scratches, dents, marring, stripping, peeling, reactions, or fading; damage due to incorrect installation, vandalism, misuse, accident wear and tear from normal use; exposure to extreme weather, exposure to salt or chlorine water, damage due to sand, salt spray, or other abrasive and corrosive material; unauthorized repair or modification, abnormal use, or lack of maintenance. The warranty does not cover damages due to “acts of God” such as hail, flooding, lightning, tornadoes, sandstorms, shifts of terrain, earthquakes, mudslides, and windstorms. In the unlikely event of failure, Spectrum Aquatics reserves the right to alter the design, color, or contributing factors to rectify the condition and help prevent any future reoccurrence(s). Spectrum Aquatics has the option to repair or replace any defect in materials. The warranty is void if any changes, modifications, additions, or attachments are made to the product without the written consent of the manufacturer.

Spectrum Aquatics excludes any implied warranty of merchantability, fitness, or purpose, and there are no warranties which extend beyond the description of the face hereof. Under no circumstances will Spectrum Aquatics be responsible for any indirect, special, consequential, incidental, or liquidated damages due to breach of warranty and such damages are specifically excluded from the warranty. The owner shall notify Spectrum Aquatics with original Sales Order Number issued from Spectrum Aquatics to arrange for an inspection within 30 days after discovery of any defect under this warranty and before any alteration or repair is made or attempted. This Limited Warranty shall be null and void if the owner makes any alterations in design. This warranty is the only express warranty given by the company. No person has authority to change or add to these obligations and liabilities. The company reserves the right to determine whether the fault is caused by faulty workmanship, material, or the part that is defective. This warranty is valid only if the structures are installed in conformity with instructions provided by Spectrum Aquatics using approved Spectrum Aquatics parts. Spectrum Aquatics will deliver the repaired or replacement part or parts to the site free of charge but will not be responsible for labor or the labor costs of replacement. Warranty claims must be filed within the applicable warranty period and accompanied by a sales order or invoice number.
